**1. Welcome, Introduction & Norms**: Norms of JRM SAC meetings

Principal Laurie was not able to attend and sent his regrets. Ms. Harrison and Ms Graham attend in his stead.

#### 2. Facilities Update:

Check if anyone from the facilities office is attending the SAC meeting and offer them a forum for updates.

Thank you to the District Facilities department for their continued engagement in our community and their partnership.

- Extra custodial position for Masterman.
- BE transition: Thank you to Mr. Terence Woods
- A new building engineer will be incoming following the departure of Mr. Woods. They will meet with Mr. Woods to ensure a smooth transition.
- A new custodial staff member was hired and started last Thursday.
- The drains from the rooftop were cleared. Paint was removed to prevent the surface from being slippery. To be determined if new paint will be applied for next school year.
- Tom Sharer is retiring and will not be attending any future SAC meetings.
- Roland Hayward (Area Manager, Office of School Safety)(rhayward@philasd.org). Mr. Hayward discussed the added Philadelphia police presence around the SEPTA stop near the school (Broad and Spring Garden) to ensure the safety of the students. Approximately 15 Philadelphia police officers and 10 SEPTA police officers are stationed around the stop. Police officers are also stationed on SEPTA platforms. He noted that Philadelphia police and SEPTA police officers will issue citations to students loitering around the Broad/Spring Garden SEPTA stop.
  - Mr. Hayward also noted his role in support of schools. (e.g. ensuring that school incidents are correctly reported, supporting the school in case of fights).
  - Parents may contact the Office of School Safety via the district website.

- A parent expressed safety concerns over their student taking public transportation. They asked if the
  district works with any external outreach programs to support. Mr. Hayward stated that the district does
  work with external outreach programs. Parent also suggested having trusted school staff (climate etc)
  outside and on the train platforms to support and monitor students safety.
   Parent requested the administration have Philadelphia and Septa police officers stationed around the
  school and at Spring Garden Station attend student town halls on safety to introduce themselves to
  students and provide a primer on safety while commuting.
- A parent raised traffic areas around the school, which includes cars double parked on Spring Garden and vehicles speeding around the school. Suggestion was to reach out to the Community Relations of Philadelphia Police and the Streets department and PPA regarding traffic enforcement, parking enforcement as well as speed dampening measures.

  - In addition to the approved position, there is currently one more vacancy that needs to be filled
- Crossing Guard Mr. Terrence Henry
  - Mr. Ladj is the new math teacher. He joined the meeting and introduced himself to the meeting attendees.

- Grade Book Updates: consistent weekly updates to grades update on process
- Communication to families on how to access PSSA and Keystone score Dhivya is preparing a stepper for Principal Laurie to send out to families.
  - Ms. Graham will discuss with the leadership cabinet over homework due dates/times.
  - Grading. The district requires teachers to post 2 grades per week. But there may be some flexibility. The
    administrative team runs reports via Infinite Campus to see teacher grade posting frequencies. They have
    been in communication with teachers to ensure assignments are regular and student assessments are
    timely made.

### III. Testing PSSA/PSAT/SAT and AP Self-Study

- AP Self-Study assembly: Assembly completed. Update
  - Ms. Harrison stated there was an assembly for students interested in AP self-study. A detailed letter was sent home to families with the purpose of ensuring families/students are aware of the rigor with self-study.
  - Two points of note- Masterman will be a testing site for courses that are offered in Masterman if students are self-studying but if the courses are not offered at Masterman, students need to find their testing site from the College Board website.
  - The deadline to commit to self study is Nov 15th.
  - Students who are enrolled in an AP class have their exam automatically ordered.

- You can self-study for any AP courses offered. Students need to have a plan and be mindful of the workload.
- SAT fees 2 extra opportunities possible through SDP Update on how students can request these codes.
  - Other district students (e.g. Central HS, Palumbo) can email their school counselor to request these codes.
  - Ms. Harrison will speak with Masterman counselors.

#### IV. Student Life:

#### Attendance:

Absent exempt for sanctioned school activities process - update

Also <u>the school handbook</u> directs families to Ms. Lambert to report absences and Ms. McIntyre to rectify attendance issues. Policy clarification - update

- Per Ms. Harrison, the school handbook will be updated to reflect that Ms. Lambert handles absences. The administration will also meet to discuss drafting language to students on absences.

### Lateness due to SEPTA delays:

Communication on process to correct attendance due to Septa Lateness

SEPTA Cuts/ Unreliability still affects student's ability to sometimes get to school and return home at a reasonable hour. Septa has not restored all bus routes and the regional rail commuters are under particular strain with uncertainties.

Ms. Harrison will discuss with the leadership team and communicate to the community on what the process and when Septa related absences will be excused.

## VII. NEW Business from SAC input forms:

I. Advisory: Thoughtful input around advisory/study hall: I think that the school community generally agrees that this is valuable, however, my thought is that the time could be more intentional, especially if we treat it as a shared responsibility between teachers and students. A meaningful start to the day, consistent across all Sections. A well-designed advisory (framework) can help students feel connected, organized, and aware of what's happening in their school community.

- Per Ms. Graham, the district-provided guidance to teachers on how to handle Advisory. The administration provided additional resources to teachers.
- Teachers cannot expect teachers to plan and implement things during advisory as it is non-instructional time. So it cannot be structured.
- Extended advisory is the only time where it can be structured and teachers can be asked to use district mandated resources
- Positive Behavioral Intervention and Supports is a school opted program from the district. Ms. Harrison will review the handbook and ensure the section related to this reflects the current school program.
- Parent question why do high school students have the same advisor across all 4 years?
  - Keeping them with the same advisor helps build relationships with students that turns into a mentorship across their high school.
- II. **Grade field trips and end of year activities:** Request for clarification of process regarding how activities/field trips and end of year trips are organized for each grade.
  - Within the grades each grade sponsor determines with the students or the SGA to figure out what the year end trip would be and in addition tradition determines what trips take place.
  - They are being mindful and proactive about planning trips and being intentional about picking trip windows.
  - Historically 8th grade went to DC, 9th went Baltimore, 10th went to NY, 11th went to DC again and 12th went to Poconos.
- III. **Microwave use for students is back:** I wanted to shout out a huge thank you to the Masterman administration for once again allowing microwave use in the cafeteria. The loss of the microwave for a few years had a significant impact on the students and was a punishment for all when one or two? put metal in the oven. Thank you for bringing this back and trusting the children again.
- IV. **Community Service requirement:** Does Masterman have a community service requirement? Does student community service hours volunteering for the school get logged anywhere? (2 inputs)
  - Per Ms. Graham, community service requirements are determined school by school. Masterman does not have service requirements. Mr. Gilken documents and tracks student hours. Ms. Graham to follow up with Mr. Gilken on the process and how to report to colleges.
  - Honor societies require students to provide community service..
- V. **Student Transportation:** I have a question about the flat rate program for Masterman 5-8 or above grade. Can we apply for it? I did apply for sept, but never got the check.
  - A parent noted that Masterman does not qualify for the flat rate program because no buses are provided instead students are provided Septa Passes if eligible.
- VI. **Halloween MS:** What happened to the Halloween door decoration contest? Is MS being punished for something too? kids love this so much every year, why did the administration take it away this year
  - Ms. Geiger stated that some teachers did not participate because they may have lacked time or that it took away from instructional time.
